This depth will ensure that most emissions are condensed within the product, that excessive product vapourisation does not occur, and that the possibility of fire is reduced. Section 8. Exposure controls and personal protection

Hand protection

Wear chemical resistant gloves. Recommended: Nitrile gloves.
